### **Terms and Conditions**

#### **Agreement between User and momothedoula.com**

Welcome to momothedoula.com. The momothedoula.com website (the "Site") is comprised of various web pages operated by Momo the Doula. momothedoula.com is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of momothedoula.com constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

### **Privacy**

Your use of momothedoula.com is subject to Momo the Doula's Privacy Policy. Please review our Privacy Policy, which also governs the Site and informs users of our data collection practices.

### **Electronic Communications**

### **Cancellation/Refund Policy**

In the extremely unlikely event that neither myself or any back-up doulas attend your birth, and the absence of doula support at your birth is due to my error, there will be no charge for services and your fee (minus the retainer) will be refunded. If you choose to cancel your birth support package, your fee will be refunded minus your retainer and any fees owing for rendered services (including meetings, phone/text support, on-call availability, or any other support services provided). Any other circumstances out of our control that result in the absence of doula support at your birth will be addressed on a case-by-case basis and may or may not result in a partial or full refund. Refunds must be requested by 6 weeks postpartum. No refunds are available after 6 weeks from the date of your baby's birth. Should the client choose to end the contract before the remainder of their support hours have been used, or choose not to use the rest of their support hours, no refund for the unused hours will be given. Support hours are non-transferable and may not be used towards any other services. Hours can not be redeemed by anyone other than the client. All support hours expire one year after this contract has been signed.

The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.
